## INSTRUCTIONS

1. A Shareholder/Beneficial owner desiring to exercise vote by Postal Ballot may complete this Postal Ballot Form (no other form or photocopy thereof is permitted) and send it to the Scrutinizer in the attached self addressed postage pre-paid envelope. Postage will be borne and paid by the Company. However, envelopes containing Postal Ballot Form (s), if deposited in person or sent by courier or registered/speed post at the expense of the registered Shareholder/Beneficial owner will also be accepted.
2. Alternatively, a Shareholder(s)/Beneficial owners may cast their votes electronically through e-voting instead of dispatching Postal Ballot Form. E-voting is optional. The detailed procedure is enumerated in the Notes to the Postal Ballot Notice.
3. The self addressed postage pre-paid envelope bears the name of the Scrutinizer appointed by the Board of Directors of the Company.
4. This Form should be completed and signed by the Shareholder(s)/Beneficial owner(s) (as per the specimen signature registered/ recorded with the Company/Depository Participants). In case of Joint holding, this Form should be completed and signed by the first named Shareholder/Beneficial owner and in his absence, by the next named Shareholder/Beneficial owner.
5. Assent or dissent to the proposed resolution may be recorded by placing a tick mark (✓) in the appropriate column. The assent or dissent received in any other Form shall not be considered valid.
6. Incomplete, unsigned or incorrect Postal Ballot Forms will be rejected.
7. Voting through Postal Ballot cannot be exercised by proxy
8. There will be only one postal ballot form for every Folio/Client ID irrespective of the number of joint Shareholder(s)/Beneficial owner(s).
9. Duly completed postal ballot form should reach the Scrutinizer not later than the close of working hours (i.e. 5:00 p.m.) on 26<sup>th</sup> May, 2017. All postal ballot forms received after this date would be treated as if reply from such Member had not been received.
10. A Shareholder/Beneficial owner may request for a duplicate Postal Ballot Form, if so required. However, the duly completed duplicate Postal Ballot Form should reach the scrutinizer not later than the last date of receipt of Postal Ballot Form, i.e. 26<sup>th</sup> May, 2017 till 5:00 p.m. (IST)
11. In case of shares held by the Companies, Trusts, Societies etc., the duly completed Postal Ballot Form should be accompanied by a certified true copy of Board resolution/ authority letter, authorizing the signatory to execute and sign the Postal Ballot Form.
12. Shareholders/Beneficial owners are requested not to send any other paper along with the Postal Ballot in the enclosed self addressed postage pre-paid envelope, in as much as, all such envelopes will be sent to the Scrutinizer and any extraneous paper found in such envelope would be destroyed by the Scrutinizer and the Company would not be able to act on the same.
13. Voting rights shall be reckoned on the paid up value of Shares registered in the name of the Shareholder(s)/Beneficial owners as on 21<sup>st</sup> April, 2017.
14. The Scrutinizer's decision on the validity of a postal ballot form would be final and binding.
15. The results of the postal ballot will also be posted on the website of the Company [www.zodiaconline.com](http://www.zodiaconline.com) and also published in the newspaper(s) for the information of the Shareholder(s)/Beneficial owners.
